For areas within 1 mile of salt or brackish water, cleaning must be performed quarterly.. Failure to clean product in accordance with these requirements will void this warranty.
- Feeney products are designed to work together as a complete system. Utilizing components in other systems could void the warranty.
- Feeney, Inc. has established installation parameters in an effort to provide code compliant guard systems. These parameters are based on engineering calculations in accordance with typical building code requirements in most jurisdictions.
